

Level 3 Qualifications

Level 3 is for anyone new to FM with less than two to three years' experience in an FM role, or first line managers seeking an FM qualification. They will help learners to develop knowledge and specific skills in facilities management alongside a wide range of leadership and management skills.

How do they work?

Within each level there are 3 sizes of qualification (Award, Certificate and Diploma). All qualifications are made up of units of learning, which have credit values [see overleaf]. For each unit you will need to complete a work based assessment to be submitted post your course.
